WE, the undersigned natural persons of the age of—twenty-one (21) years or more, at least three of whom are citizens of the state of Texas, acting as incorporators of a corporation, do hereby adopt the following Articles of Incorporation for such Corporation:

ARTICLE I.

The name of the Corporation is SKYUNE PANCHEJATES Water Supply Corporation.

ARTICLE II.

The Corporation is a non-profit corporation organized UNDER CHAPTER 67 OF THE TEXAS WATER COPE, under Article 1434a of the Revised Civil Statutes of the Texas of 1925, as amended, and as supplemented by the Texas Non-Profit Corporation Act, Article 1396-1.01, et seq., of the Revised Civil Statutes of Texas, as amended, and is authorized to exercise all powers and rights incidental in carrying out the purposes for which the Corporation is formed, except such as are inconsistent with the express provisions of these Acts.

ARTICLE III.

The period of its duration is perpetual.

ARTICLE IV.

The Corporation is formed for the purpose of furnishing a water supply for general farm use and domestic purposes to individuals residing in the rural community of SMUNE AANCH ESTATES WIMPERIEY, Texas, and the surrounding rural areas. The places where the business of the Corporation is to be transacted shall be the SMUNE PANCH ESTATES Community in WIMPERIEY, HAYS County, Texas, and the surrounding rural areas.
